Prayer in WMP(MD). 2422 and 2423 of 2017 :

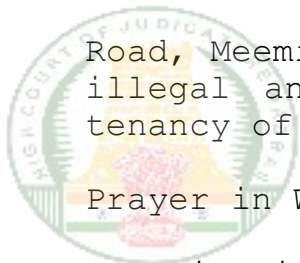

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus to call for the Impugned Notice dated Nil, under Proceedings No. Nil, on the file of the 2nd respondent pertaining to classifying the petitioner tenant as encroacher by mandating the petitioner to be evicted from D.No.853, Vannakuttai



Road, Meemisal Village, Pudukottai District and to quash the same as illegal and further direct the 2nd respondent to regularize the tenancy of the petitioner in the manner known to Law.

Prayer in WP(MD). 10256/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus to call for the impugned notice dated Nil, under proceedings No. Nil, on the file of the 2d respondent pertaining to classifying the petitioner tenant as encroacher by mandating the petitioner to be evicted from Shop No.837 and 838, East Coast Road, Meemisal Village, Pudukottai District and to quash the same as illegal and further direct the 2nd respondents to regularize the tenancy of the petitioner in the manner known to law.
