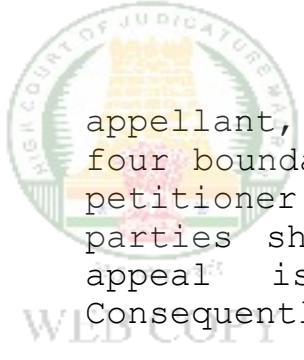
Prayer in WP(MD). 14598/ 2016 :
