PRAYER IN WMP(MD) No.4957 of 2017:

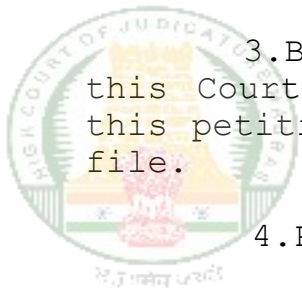

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the respondent to receive the petitioner's application for grant of transit pass for transportation of minerals in respect of the lease granted on 09.03.2012 in Roc.No.319 of 2011 over the property comprised in S.No.100/1B and pass appropriate orders in terms of Rule 6(3) of the Tamil Nadu Prevention of illegal Mining and Transportation and Storage of Minerals and Mineral Dealers Rule 2011.

ORDER : This petition coming on for hearing on this day upon perusing the petition and affidavit and material papers of this petition and upon hearing the arguments of Mr.S.R.RAJAGOPAL, Advocate for the petitioner and Mr.A.ANANDARAJ, Government Advocate for the Respondent, this court made the following order:-
