2.The request of the appellant for re-transfer of the land was rejected by the Single Judge, by considering the fact that the land is required for smooth alignment of the Road. Hence, we find no merit in the writ appeal.

3.Accordingly, the writ appeal is dismissed with liberty to approach the respondents for enhancement of compensation. If any representation is received, the respondents shall consider the same on merits and in accordance with law. No costs.
