PRAYER IN WMP(MD) No.5686 of 2017

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the Respondents No.1 to 3 to evict the encroachment made by the Respondents No.4 to 9 in the Oorani situated at Trichy District, Manapparai Taluk, F.Keezhaiyur Village in S.F.No.57 by considering the Petitioners representation dated 20.02.2016 within the time frame as fixed by this Honble Court.
