It is seen from the records that the petitioner has given a representation for conducting Adal Padal Programme on 08.06.2017 and the same has been rejected by the second respondent on the ground of law and order problem. The reason assigned by the second respondent for rejecting the representation given by the petitioner is not proper. Under the said circumstances, this Court is inclined to pass the following order.

4. In fine, this writ petition is allowed in part without costs and the impugned order dated 23.05.2017 passed by the second respondent is quashed. However, the second respondent is directed to look into the representation alleged to have been given by the petitioner afresh and dispose of the same as early as possible.
