ORDER

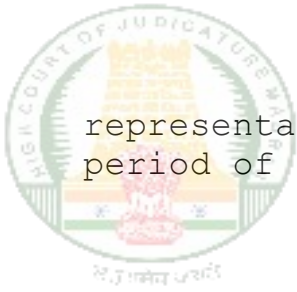
[Order of the Court was made by **A.SELVAM, J.**]
