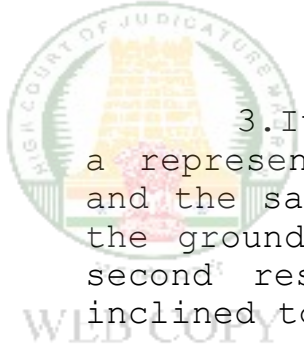

It is seen from the records that the petitioner has given a representation for conducting Kabadi Tournament on 10.06.2017 and the same has been rejected by the second respondent simply on the ground of law and order problem. The reason assigned by the second respondent is not proper and therefore this Court is inclined to pass the following order.

4. In fine, this Writ Petition is allowed in part without costs and the impugned order dated 14.05.2017 passed by the second respondent is quashed. The second respondent is directed to look into the representation alleged to have been given by the petitioner afresh and pass suitable orders within a period of two days.
