2. When the writ petition was taken up for hearing, the learned Special Government Pleader placing reliance on the proceedings of the Tahsildar, Srirangam in Na.Ka.No.A4/963/2017, dated 12.06.2017 submitted that there is no proposal to take the sand lorries through Indira Sundarnagar street.
