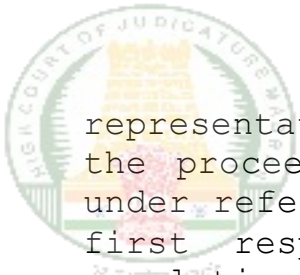

2. Mr.C.Selvaraj, learned Special Government Pleader takes notice for the first respondents.

Though the Writ Petition is for issuing a Writ of Mandamus to give a positive direction to the respondent, the learned counsel for the petitioner submits that the petitioner will be satisfied if a direction is issued to the respondent, to consider the representation of the petitioner, dated 22.12.2016.

5. Having regard to the limited scope of the prayer, that is now sought before this Court by the learned counsel appearing for the petitioner, without expressing any opinion on the merits of the petitioner's case, this Court is inclined to pass the following direction:-

"The second respondent is directed to consider the representation of the petitioner dated 22.12.2016, and pass appropriate orders on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order."

6. With the above direction, the Writ Petition is disposed of. No costs.
