4..Considering the representation made on the side of the respondents, the relief sought in the Writ Petition has become infructuous and therefore, the same deserves to be dismissed.

5.In fine, this Writ Petition is dismissed. No costs. Consequently, connected Miscellaneous Petition is dismissed.
