3.Heard Mr.R.Alagumani, learned counsel appearing for the petitioner, Mr.M.Alaga Thevan, learned Special Government Pleader appearing for the respondent.

4.The case of the petitioner is that the petitioner is the owner of the property in Survey Nos.166/2B, 166/4A and 166/4B and she is in possession and enjoyment of the said property. While so, one Chinnakaruppan filed a petition before the respondent in T.R.No.7 of 2013 claiming tenancy rights. The petitioner opposed the petition and also produced evidence in support of her case.
