For Petitioner : Mr.D.Anbarasu in both W.Ps.

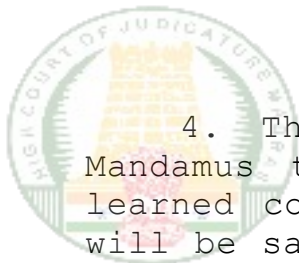
