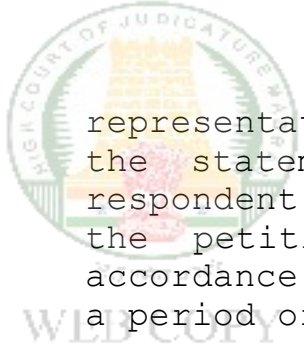
O R D E R

The petitioner is before this Court by way of this writ petition seeks for a direction upon the respondents 1 and 2 to remove the alleged encroachment made by the third respondent by considering his representation dated 12.06.2017.

2.According to the petitioner, the third respondent is a very influential person and he encroached a land allotted for communal purpose.

3.Since the representation has been given on 12.06.2017, the authority should be granted a reasonable time to consider the



representation. Therefore, without going into the correctness of the statement made by the petitioner, we direct the second respondent to consider the representation, after issuing notice to the petitioner as well as third respondent and proceed in accordance with law as expeditiously as possible preferably within a period of eight weeks.

4.The writ petition is disposed of with the above direction. No costs.
