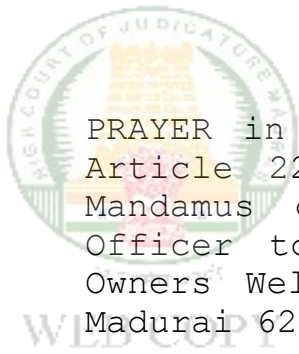

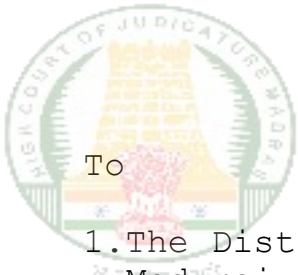
COMMON ORDER
