PRAYER: Writ Petition is filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondents 1 to 4 herein, especially the third and fourth respondents herein, to consider the representation of the petitioner, in parawise, dated 08.02.2017 and initiate action, against the fifth respondent, for committing financial irregularities after forging the documents, for issuing uncrossed cheques without doing works in Panchayat, on the basis of the audit reports from the year 2005-2006 to 2012-2013, by initiating criminal prosecution as well as to initiate surcharge proceedings as against the fifth respondent for the commitment of financial irregularity in the capacity of Panchayat President and to recover the amount from the fifth respondent as per law.
