ORDER

This writ petition is filed seeking a writ of Mandamus to direct the respondents to give permission to install the statue of Perarasar Perumpidugu Mutharaiyur Statue in private patta land in Survey No.596/1B situated at Velayuthampatti Village, Kunnampatti Post, Natham Taluk, Dindigul District, on the basis of the petitioner's representation dated 22.05.2017.
