As per endorsement made by the petitioner, this writ petition is dismissed as withdrawn. No costs.

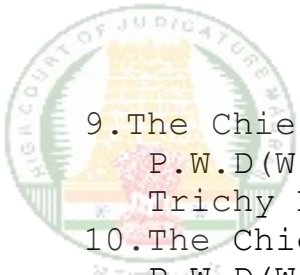
