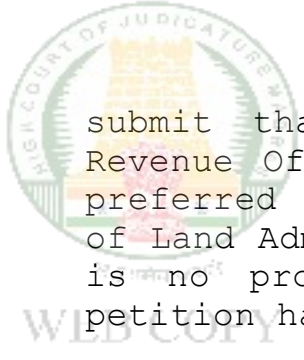
ORDER

submit that aggrieved over the order passed by the District Revenue Officer, Tirunelveli, the petitioner and two others have preferred an appeal before the first respondent/the Commissioner of Land Administration, in the month of October 2016. Since there is no progress for the past eight months, the present writ petition has been filed seeking the above said relief.

4. Considering the limited scope of the prayer sought for by the petitioner, this Court, without going into the merits of the matter, directs the first respondent to pass appropriate orders on the petitioner's appeal dated 22.10.2016 on merits and in accordance with law, after giving notice to the interested parties, within a period of eight weeks from the date of receipt of a copy of this order.

5. With the above direction, this Writ Petition stands disposed of. No costs.
