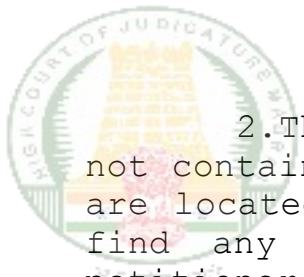

The petitioner filed this writ petition in *pro bono publico* to direct the respondents to close the liquor shop bearing NOS.6842 and 6843, situated at Keelakarai Taluk, Ramanathapuram District.



2.The affidavit filed in support of the writ petition does not contain a clear indication as to whether the shops in question are located within the prohibited distance. We therefore, do not find any reason to issue a mandamus as prayed for by the petitioner.

3.We make it clear that this order would not stand in the way of the local people from approaching this Court, in case the TASMAC shop is a perennial source of nuisance.
