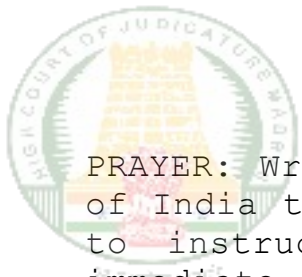

4.The writ petition is disposed of with the above observation. No costs. Consequently, the connected miscellaneous petition is closed.

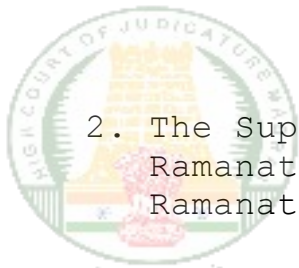
