5.Having regard to the limited scope of prayer in the Writ petition, without expressing any opinion on the merits of the matter, the respondents are directed to consider the representation of the petitioner, dated 05.12.2016, and pass orders on merits and in accordance with law, after giving an opportunity of personal



hearing to the petitioner, within a period of eight weeks from the date of receipt of a copy of this order.

6. Accordingly, the Writ petition is disposed of. No costs.
