This writ petition has been filed in public interest. The writ petitioner is aggrieved by the non-completion of the construction works of "58 Girama Pasana Kalvai Thittam".

2.This project was conceived several years ago. This envisaged providing irrigation facilities to 58 villages in and around Usilampatti Taluk.

3.This Court also heard Mr.C.Jeyaraj, President of Usilampatti Taluk 58 Grama Paasana Vivasayigal Sangam in person, representing the members of the Sangam, pursuant to allowing the impleading petition.

4.The District Collector has filed a report stating that the pending works will be completed on or before 31.03.2018. This undertaking filed by the District Collector is placed on record. Accordingly, a direction is issued to the respondent authority to complete all the pending works under the said "58 Girama Pasana Kalvai Thittam" on or before 31.03.2018.

5. This writ petition is accordingly allowed. No costs. Consequently connected miscellaneous is closed.

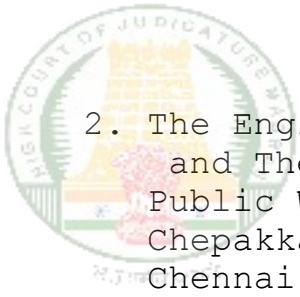
