**ORDER**

The Writ Petition has been filed challenging the correctness of the impugned suspension order issued in No.D01377-Sa10-ONaP-ThaAPoKaTvl-17 dated 12.07.2017. The petitioner was working in the Tamil Nadu State Transport Corporation as Driver.
