The petitioner filed the writ petition to direct the respondents 1 and 2 to consider the representations submitted by the petitioner, dated 27.07.2017 and 04.08.2017 respectively.

2. According to the petitioner, he has filed a police complaint against the fourth respondent for assaulting the



petitioner. Even though a crime case been registered on 17.07.2017, the grievance of the petitioner is that the third respondent did not conduct any investigation on his complaint. Hence, he made a representation to the higher authorities to direct the third respondent to conduct investigation.
