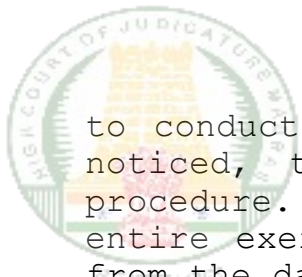

to conduct a survey of the street in question. If encroachment is noticed, the same shall be removed by following the statutory procedure. Notice shall be issued to the interested parties. The entire exercise shall be completed within a period of three months from the date of receipt of a copy of this order.
