Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to grant permission to conduct Innisai Kacheri and Adal Padal scheduled to be held on 30.09.2017 and 01.10.2017 respectively at 10.00 p.m to 01.00 a.m in "Thiruvizha" at Arulmighu Amman Kovil, Sivakamipuram, Alangulam Taluk, Tirunelveli District.

O R D E R

This Writ petition is filed for issuing a Writ of Mandamus, directing the respondents to grant permission to conduct Innisai Kacheri and Adal Padal scheduled to be held on 30.09.2017 and 01.10.2017 respectively at 10.00 p.m to 01.00 a.m in "Thiruvizha" at Arulmighu Amman Kovil, Sivakamipuram, Alangulam Taluk, Tirunelveli District.

2. Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents.

3. The learned counsel for the petitioner submitted that the respondents have already decided to conduct "Innisai Kacheri and Adal Padal" programme on 30.09.2017 and 01.10.2017 respectively in connection with "Thiruvizha" in Arulmighu Amman Kovil,



Sivakamipuram, Alangulam Taluk, Tirunelveli District. He further submitted that in this connection, a representation was given to the second respondent on 04.09.2017, with a request to grant permission and protection to conduct the programme on the above said date. However, the second respondent police has not yet considered the said representation and hence, the petitioner is before this Court with this Writ Petition.

4. The learned Additional Government Pleader appearing for the respondents submitted that this Court may grant permission for "Innisai Kacheri and Adal Padal" programme subject to stringent conditions.

5. Considering the facts and circumstances of the case, the Writ Petition is disposed of with the following directions:

The second respondent/The Inspector of Police, Pavoorchathiram Police Station, Tirunelveli District, is directed to consider the representation of the petitioner, dated 04.09.2017 and to give permission and to provide police protection for "Innisai Kacheri and Adal Padal" programme perform by "Alangulam Muthamil Dance Group" in connection with "Thiruvizha" in Arulmighu Amman Kovil, Sivakamipuram, Alangulam Taluk, Tirunelveli District, scheduled to be held on 30.09.2017 and 01.10.2017 respectively, subject to the following conditions;

(a) the "Innisai Kacheri and Adal Padal" programme perform by "Alangulam Muthamil Dance Group" in connection with "Thiruvizha" in "AArulmighu Amman Kovil, Sivakamipuram, Alangulam Taluk, Tirunelveli District, scheduled to be held on on 30.09.2017 and 01.10.2017 respectively, should be completed before 10.30 p.m or as may be directed by the second respondent police.

(b) there should not be any kind of obscene dance or vulgar dialogues during the performance, by any one of the participants;

(c) double meaning songs should not be played so as to spoil the minds of students and the youth;

(d) no dance or songs, touching upon any political party or religion, community or caste be played;

(e) no flex boards in support of any political party or religious leader be erected;

(f) the function should not affect either religious or communal harmony and shall be conducted without any discrimination based on caste;

(g) if there is any violation of any one of the conditions imposed, the concerned Police Officer is at liberty to take necessary action, as per law and stop such performance;

(h) similarly, the Police is empowered to stop the programme, if it exceeds beyond the permitted time;



(i) the participants of the programme shall not intake any kind of in-toxic substance or liquor during the programme; and

(j) if any untoward incident takes place, the organizers of the programme be made responsible for the same.

6. It is open to the second respondent police to put any further restrictions or to impose any conditions purely in the interest of preserving public order and tranquillity. There can be a total ban for putting up any Flex Boards representing any community. No costs.
