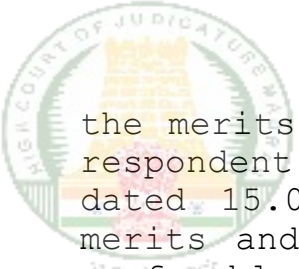
2. Mr. G. Muthukannan, learned Government Advocate takes notice for respondents. By consent, this Writ Petition itself is taken up for final disposal.
