3.Accordingly, the writ petition stands dismissed. No costs. Consequently, the connected miscellaneous petition is closed.

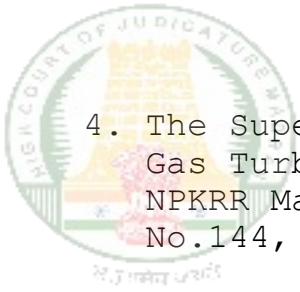
