Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying for the issuance of a Writ of Mandamus, directing the 1st and 2nd Respondent herein to approve the petitioner's appointment as Assistant Professor in Physics in the Women's Christian College, Nagercoil, in the sanctioned retirement vacancy of Dr.J.Beula with effect from 15.06.2017 in the light of approval given by the 1st Respondent to the similarly placed persons appointment vide his proceedings in Na.Ka.No.708/F2/2017 & Na.Ka.No.710/F2/2017 dated 06.07.2017, with monetary and all other attendant and service benefits based on the representation dated 20.07.2017 given by the petitioner.

ORDER

This writ petition has been filed for a direction to the respondents 1 and 2 to approve the petitioner's appointment as Assistant Professor in Physics in the Women's Christian College, Nagercoil.

3. In view of the petitioner has sought for a larger relief, learned counsel for the petitioner submits that the representation



dated 20.07.2017, made by the petitioner for the same relief has not yet been disposed by the concerned authority and the petitioner would be satisfied if a direction is given to the 1st respondent to consider the said representation and pass orders on merits and in accordance with law and he has made an endorsement to that effect.

4. Recording the submission and endorsement so made, this Court, without expressing any view on the correctness or entitlement of the claim made, directs the first respondent to consider the representation dated 20.07.2017, made by the petitioner and pass reasoned orders on merits and in accordance with law and communicate such decision to the petitioner and file a report of such compliance before the Registrar (Judicial), Madurai Bench of Madras High Court, Madurai on or before 31.12.2017.

5. Accordingly, this Writ Petition is disposed with the above directions. No costs. Consequently, connected Miscellaneous Petition is closed.
