promoted to the post of Graduate Assistant on 16.7.1997. Now the Petitioner is working in Government Higher Secondary School, Thirumangalam, Madurai District. While so the third respondent has placed the Petitioner's name below her juniors in the attendance register. In this regard the Petitioner has submitted a representation to the third respondent on 1.9.2017 and since the said representation did not evoke any response, the petitioner is before this Court with the relief stated supra.

4. The counsel for the respondents would submit that it is agreeable for the respondents to consider the representation of the petitioner and pass orders thereon.

5. In view of the submission, the respondents concerned is directed to consider the representation of the petitioner, dated 1.9.2017 and to pass appropriate orders on the same in accordance with law, within a period of two months from the date on which a copy of this order is made ready, preferably on or before 6.4.2017, if there is no legal impediment to do so. No costs.
