Prayer: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the first respondent to pay the petitioner 18 % interest for the belated payment of Gratuity, Provident Fund and further directing the second respondent to pay a sum of Rs.72,012/- towards the arrear of pension commutation together with 18% interest per annum within a time frame as may be fixed by this Court.

O R D E R

This Writ Petition has been filed for issuance of Writ of Mandamus, directing the first respondent to pay 18 % interest for the belated payment of Gratuity, Provident Fund and further directing the second respondent to pay a sum of Rs.72,012/- towards the arrear of pension commutation together with 18% interest per annum within a time frame as may be fixed by this Court.

2.This Court in similar circumstances by order dated 09.01.2017 in W.P.(MD)No.354 of 2017 has held as follows:-

"13.Following the Division Bench Judgment of this Court, the Courts are consistently passing orders for payment of retirement dues with interest at 6 % p.a. with default interest of 18 % p.a.
