Prayer: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the first and second respondents to consider and pass orders on the petitioner's representation dated 27.08.2015 so as to enable the third respondent to include the petitioner's Sub Caste namely, Arunthathiyar in the Transfer Certificate issued by the third respondent in Serial No.143/1999-2000 dated 09.11.1999 based on her Community Certificate within the time limit that may be stipulated by this Court.

The writ petitioner belongs to Arunthathiyar Community, but in the Transfer Certificate issued by the third respondent it has been generally mentioned that she belongs to Scheduled Caste. During the relavent time there was no sub reservation provided for Arunthathiyars. The petitioner now seeks to pursue her higher studies but, she is not able to avail the quota meant for Arunthathiyars, since her community has not mentioned in the



transfer certificate. She had given an application to the third respondent seeking specific mentioning of her community in her Transfer Certificate. The request of the writ petitioner is reasonable.

2. Therefore, this Court directs third respondent to incorporate the community of the petitioner namely, Arunthathiyar in the Transfer Certificate issued to her in Serial No.143/1999-2000 dated 09.11.1999.

3. Accordingly, this writ petition is allowed. No costs.
