2.Heard Mr.R.Sathish, learned counsel appearing for the petitioner, Mr.S.Sathish Kumar, learned Additional Government Pleader, who takes notice on behalf of the respondents.

3.The learned counsel for the petitioner submits that the petitioner would avail the alternative remedy of preferring



further revision before the Registrar of Co-operative Societies against the impugned order of the second respondent / Deputy Registrar, Co-operative Societies and seeks permission to withdraw the Writ Petition and he has also made an endorsement to that effect.
