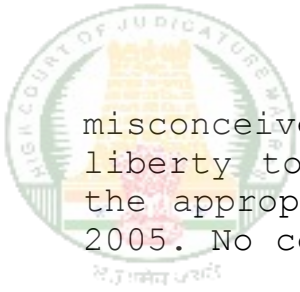

This writ petition is filed seeking for mandamus directing the respondents to furnish informations sought for by the petitioner under Right to Information Act, 2005 made through his application dated 10.12.2016.

2. The grievance of the petitioner is that the said request made by the petitioner seeking for information under Right to Information Act, 2005 is not furnished by the first respondent till this date.

3. Needless to state that if information is not furnished within the time stipulated under the Act, the petitioner has to resort to the remedies available under the Act as against such respondents. Filing of writ petition seeking for mandamus is not proper course of action. Therefore, I find that the present writ petition is totally



misconceived. Accordingly, this writ petition is dismissed with liberty to agitate the matter in the manner known to law before the appropriate forum as provided under Right to Information Act, 2005. No costs.
