**O R D E R**

3.Considering the limited scope of the prayer now sought before this Court by the learned counsel for the petitioner, without expressing any opinion on the merits of the petitioner's case, this Court is inclined to pass the following direction:

"The second respondent is directed to consider the petitioner's representation dated 13.11.2017 and pass order on the same on merits and in accordance with law and take appropriate action if necessary within a period of two weeks from the date of receipt of a copy of this order."

4.With the above observation, the Writ Petition is disposed of.
