This writ petition has been filed under Article 226 of the Constitution of India praying to direct the respondents not to issue patta to private individuals in respect of Survey Nos.223 and 224, Kinnimangalam Village, Tirumangalam Taluk, Madurai District, by way of issuing a writ of mandamus.

2.The learned Additional Government Pleader appearing for the respondents has contended to the effect that Survey Nos.223 and 224 are classified as Government poromboke land and so far



nobody has been granted patta.

3.The learned counsel appearing for the petitioner has contended that on 26.10.2014 and 05.12.2016, representations have been given, but the same have not been considered.
