According to the petitioner, the property in question belongs to him and neither civil suit nor rival claim, whatsoever, is pending in respect of the same and as such, he has submitted an online application dated 02.11.2017, before the authorities, for measurement of his property. Since the same has not been considered so far, the petitioner is before this Court with the above prayer.



4. When the matter is taken up for hearing today, the learned Counsel for the petitioner submitted that it would suffice, if his application dated 02.11.2017 is disposed of by the second respondent, on merits.
