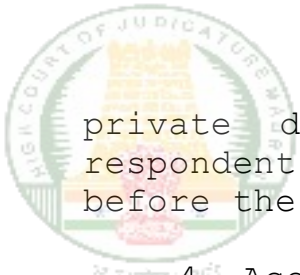
### ORDER
