O R D E R

The petitioner seeks for a direction to the respondent to consider her representation, dated 12.09.2016, through which, she seeks for reclassification of the land situated at Survey No.54.2 measuring about 2.94 acres in No.47, Mela Veli Village, Thanjavur Taluk and District.

2.Whether the petitioner is entitled to get reclassification as sought for by her in the representation or not, is for the respondents, more particularly, the third respondent to consider and decide and therefore, this Court, at this stage, is not expressing any view on the claim made by the petitioner.

3.Therefore, this writ petition is disposed of only with a direction to the respondent to consider the representation of the



petitioner, dated 12.09.2016 and pass orders on the same on merits and in accordance with law, after hearing the rival claimants/interested parties, if any. Such exercise shall be done by the third respondent within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
