Considering the limited scope of the prayer sought for in this writ petition and without expressing any view on the merits of the claim made by the petitioner, I only direct the 2nd and 3rd respondents to consider the representation of the petitioner, dated 01.11.2016 and pass orders on the same, on merits and in accordance with law, also by hearing other rival parties, if any, within a period of twelve weeks from the date of receipt of a copy of this order.

4. With the above direction, this Writ Petition is disposed of. No costs.
