PRAYER: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the first respondent to take action to remove the encroachment in the petitioner landed property situated in SF.No.1/16, Kayangulam Group 84, Kuttithinni Village, Thambanusilangulam Sub Division, Sivagangai Taluk and District after conducting the enquiry pursuant to the order passed by the second respondent in his proceedings in Na.Ka.Pi4/15508/2013 dated 06.05.2014 and in the mean time allow the petitioner to uprooting the Seemai Karuvelam Trees from his landed property based on the representation of the petitioner dated 07.01.2017.
