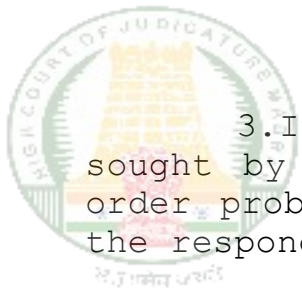

3.It is seen from the impugned order that the permission sought by the petitioner has been rejected only due to law and order problem. Further it is seen from the impugned order that the respondent has permitted to conduct other events.

4.Considering the reason given in the impugned order, this Court is of the view that the same is liable to be quashed.

5.In fine, this writ petition is allowed without costs and the impugned order dated 16.02.2017 passed by the respondent is partly quashed. The respondent is directed to look into the representation once again and pass suitable order within a period of two days.
