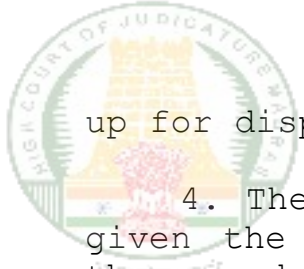
O R D E R

The Petitioner seeks for a direction to the first respondent to direct the second respondent to grant patta for the petitioner's lands situated in Old Survey No. 304/2, Natham Survey No.571/14 and its extent of 4 ½ cents= 0.0125 sq. mtrs of Puthanatham, Manaparai Taluk, Trichy District by considering his representation dated 19.09.2016.
