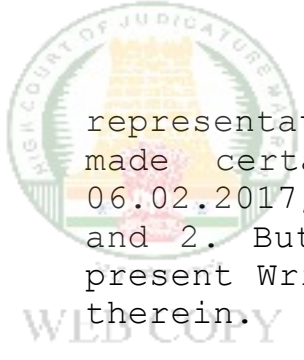
ORDER

This writ petition has been filed under Article 226 of the Constitution of India praying to direct the respondents 1 and 2 to consider the representation dated 06.02.2017 alleged to have been given by the petitioner, by way of issuing a writ of mandamus.

2.Mr.T.S.Mohammed Mohideen, learned Additional Government Pleader, has taken notice for the respondents 1 & 2. Considering the nature of the relief sought in the writ petition, notice need not be sent to the third respondent.

3.The learned counsel appearing for the petitioner has contended to the effect that the tank mentioned in the



representation is a common tank wherein the third respondent has made certain encroachments. Under the said circumstances on 06.02.2017, a representation has been given to the respondents 1 and 2. But the same has not been considered and therefore, the present Writ Petition has been filed for getting the relief sought therein.

4.Considering the fact that on 06.02.2017, a representation has been given to the respondents 1 and 2 and the same has not been considered, this Court is inclined to pass the following order.

5.In fine, this writ petition is allowed without costs and the respondents 1 and 2 are strictly directed to look into the representation dated 06.02.2017 and dispose of the same within a period of one month.
