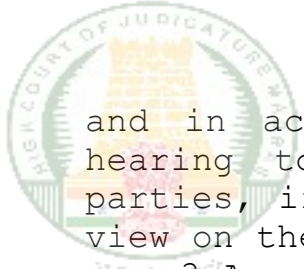

The petitioner seeks for grant of separate patta after measuring the property and sub divide the same. To that effect she has made a representation on 25.07.2016.

2. Therefore, it is for the respondents 2 and 3 to consider the request of the petitioner and pass orders on the same on merits



and in accordance with law also by giving due opportunity of hearing to the other joint pattadhars and to the interested parties, if any. This Court, at this stage, is not expressing any view on the claim made by the petitioner.

Accordingly, this writ petition is disposed of only with a direction to the respondents 2 and 3 to consider the representation of the petitioner, dated 25.07.2016 and pass orders on the same on merits and in accordance with law, after giving due opportunity of hearing to the petitioner as well as joint pattadharas and also the interested parties, if any. Such exercise shall be done by the respondents 2 and 3 within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
