A Division Bench of this Court in the decision reported in <https://hcservices.ecourts.gov.in/hcservices/> (2014 (3) CTC 676) **S.Kannan v/s The Commissioner of Police, Madurai City, Madurai & Others** has already held that the Cock Fights should



be prohibited. Therefore, following the said decision, we have to necessarily disposing this writ petition. No costs.
