"The petitioner shall appear before the respondents on 16.03.2017 and on such appearance, the respondents shall permit the petitioner to participate in the interview. Based on the decision ultimately taken by the respondents, with regard to eligibility and the other issues, final decisions will be taken by the respondents, whether to consider the petitioner under SC priority category or not. Such exercise shall be completed within a period of four weeks, thereafter.

With the above direction, the Writ Petition is disposed of. No costs. Consequently, connected Miscellaneous Petition is closed.
