This Court, therefore directs the first respondent to pass appropriate orders in accordance with law, on the writ petitioner's representation dated 13.06.2016, within a period of eight weeks from the date of receipt of a copy of this order.

2.The writ petitioner has produced a copy of the resolution passed in the Village Sabha Meeting and also other revenue records. The first respondent shall take them into account while passing order on the writ petitioner's representation.

3.This Writ Petition is accordingly disposed of. No costs.
