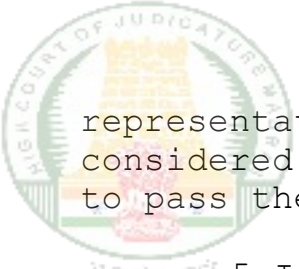
This writ petition has been filed under Article 226 of the Constitution of India praying to direct the respondent to give necessary permission for conducting Adalpadal programme in the place mentioned in the petition, by way of issuing a writ of mandamus.

2.Mr.T.S.Mohammed Mohideen, learned Additional Government Pleader, has taken notice for the respondent.

3.It is contended on the side of the respondent that with regard to Jallikattu, permission has already been rejected and two criminal cases have been registered. Under the said circumstances, permission for conducting Adal Padal Programme cannot be granted.
